## Official Information Act request

Thank you for your request under the Official Information Act 1982 (OIA) which was received by the Classification Office on 7 February 2022.

You asked:

Can you please provide the following information:

Under Section 44 & Section 45 of the Films, Videos, and Publications Classification Act 1993, for the last 5 years;

How many exemptions have been granted?

For each exemption; what was the exemption for - i.e. the publication details?

For each exemption; how long was the exemption for?

For each exemption; any conditions imposed on any exemption?

For each exemption; what was the prescribed fee (if any) for any exemption?

In responding to your request, I have weighed up the factors in the OIA, including the purposes in [section 4](#) and the principle of availability in [section 5](#).

## Response to your request

From 1 January 2017 to 7 February 2022, 63 applications for exemptions were granted, and two were declined, under section 44 of the Act.

All 65 exemption applications in this period attracted a fee of \$102.20 prescribed by Part 1, clause 7 of the [schedule to the Films, Videos, and Publications Classification \(Fees\) Regulations 1994](#).

Details about the purpose, duration, and conditions for each granted exemption are contained in the following table.
